MINUTES OF THE 8TH SOUTHERN AFRICAN AND ISLANDS HYDROGRAPHIC COMMISSION (SAIHC) CONFERENCE Walvis Bay, Namibia – 6 - 7 September 2011

Note: Paragraph numbering corresponds to Agenda Item numbering (Annex A), and not necessarily to the order in which matters were discussed.

TUESDAY 6 SEPTEMBER

Agenda item 1: OPENING AND ADMINISTRATIVE ARRANGEMENTS

Prior to the 8th SAIHC Conference, the venue was changed from Angola to Namibia.

At 0900, Mr Tony Raw, representing NAMPORT welcomed all participants to Walvis Bay, Namibia. He introduced Vice Admiral Maratos of the IHB who welcomed the Mayor of Walvis Bay, the Chairman and all the participants to the meeting.

In his address VAdm Maratos emphasized the importance of hydrography to all maritime activities indicating that although hydrography's main objective is to support safety at sea and the protection of the marine environment, its importance to many other sectors has been recognized and accepted. The tsunami disasters in the Indian Ocean and Japan, have shown that hydrographic data and information have a vital role to play not only for preparing tsunami warnings but also for research, simulation and coastal protection purposes.

The cooperation with other international organizations and maritime stakeholders is very essential. There can be no doubt that the significance of hydrography in safety at sea, global trade, the environment, our living standards and maritime security is important and forever increasing. The IHO and its Member States HO's will continue their efforts to better serve the national, regional and global needs and requirements for new, better and more accurate hydrographic products.

Mr Raw introduced the Mayor of Walvis Bay, Counsellor Derek Klazen, who officially opened the 8th SAIHC Meeting.

The Chairman welcomed all the participants and remarked that the good turnout at the 8th SAIHC conference was very encouraging. He expressed his appreciation to Namibia for hosting the meeting at such short notice. The members of industry were welcomed and thanked for their support and willingness to host functions. The list of participants is attached as **Annexure B**.

Agenda item 2: APPROVAL OF THE AGENDA (Annexure A)

The agenda was accepted and approved with the following change, *Item 9 – Election of the Chairman and Vice-Chairman and Item 10 – Any other Business*, be swapped around.

Agenda item 3: MATTERS ARISING FROM MINUTES OF 7th SAIHC MEETING

<u>Status/Review of Action List from the 7th SAIHC Meeting in Saint Denis, La Réunion.</u> The Chairman reviewed the Status of Actions. On-going items will be reflected in the revised List of Actions Table. **(Action Items 1 - 6).**

Agenda item 4: FEEDBACK FROM OTHER IHO BODIES AFFECTING SAIHC

4.1. IRCC

The Chairman highlighted the objectives of the IRCC as he felt it was of importance to the SAIHC members. He provided feedback from the 3rd IRCC Meeting with reference to the following Action Items.

- a. Mozambique and Mauritius were encouraged to approve the applications for IHO membership of Haiti and Montenegro. (Action Item 7).
- b. SAIHC strategies to involve non-IHO Member States in RHC's activities. It was decided this could be achieved by regular technical visits, correspondence forwarded by the Chairman and annual SAIHC meetings. (Action Item 8).
- c. The Chairman would provide proposals to the IRCC for inclusion in the 2013-2017 IHO Work Programme and Budget. (Action Item 9).

4.2. IHB Report

The President of the IHB, Vice Admiral Maratos, gave feedback on the structure of the IHB and other bodies that pertained to SAIHC.

In particular he focussed on providing feedback on the decision to establish The Intergovernmental Oceanographic Commission (IOC) Sub-Commission for Africa, including Adjacent Island States. He noted with appreciation the priority given in the IOC Medium-Term Strategy 2008 – 2013.

Recalling the Resolutions adopted by the IOC Assembly at its previous sessions, especially Resolution XXIV-3 on "Past, present and future of Africa within the IOC regional and international marine programmes", calling for the priority given to Africa to be properly reflected in the IOC Programmes and Budget, commensurate with its priority status.

4.3. CBSC

The chairman provided feedback on the outcomes of the 9^{TH} CBSC Meeting under Agenda Item 5.2.

Agenda item 5: SAIHC ACTIVITIES IN THE LIGHT OF THE IHO WORK PROGRAMME

5.1. IHO S-11 Region H

Mr Nelson (SA) made a presentation covering the charting progress made in charting Region H with reference to the INT Chart Catalogue, IHO S-11. He referred to the 19-year existence of the INT charting scheme since its adoption in 1992. Specific attention was made to progress made in the past two years and areas which still needed attention since the 7th SAIHC meeting. The following points of interest were mentioned:

- a. INT chart production by the UKHO, in charting agreement with Portugal, has progressed on the Angolan coast north of Namibia adjoining the South African and Region G international chart schemes. Along the east coast of South Africa, two charts INT 7550 and 7560 in advance stages of compilation, still needs to be completed. Good progress has been made by UK along the east coast of Mozambique with one chart INT 7670 still to be completed. These 3 charts, once published, will complete the INT medium scale chart coverage for the region. However, there has been some progress in coverage of the 1:1million small scale chart series.
- To date very little information has been received with regards to the progress of charting Lake Victoria. The chart scheme for Lake Malawi had not been updated.
- c. Emphasis was placed on the importance of IHO reference documents to be used in compliance with INT charting standards. Member states were encouraged to comply with these standards.
- d. South Africa, as Region H Coordinator, received a request from Norway to produce a new edition of their national chart of Bouvetoya Island No 516 as an INT chart. It was pointed out that UK is the producer of INT 2655 which included Bouvetoya as an inset plan. UK raised no objection and consensus was reached by all members. It is proposed that chart No 516 be allocated INT number INT 2656 as a stand alone chart with Norway as producer nation. The chairman agreed to draft a letter to the IHB and the Chairman of CSPCWG requesting final acceptance of this chart into the INT charting scheme. (Action item 10).
- e. A further request from France, with very good reason, is to adjust the geographical limits of INT 7722 of Tamatave (Toamasina) Harbour, the main harbour on the east coast of Madagascar. New hydrographic surveys by SHOM and increasing harbour developments realize the need for allocating an INT number to national chart No 7683. No objections were raised and consensus was reached by all members. It is proposed that the allocated INT number be INT 7723. The Chairman agreed to draft a letter to the IHB and the Chairman of CSPCWG requesting final acceptance of this chart into the INT charting scheme. (Action item 11).
- f. Chart INT 7746: Marion, Prince Edward Islands (ZA Territory), Heard and McDonald Islands (AU Territory) in the southern Indian Ocean with South Africa in conjunction with Australia, originally the UK, as producer nations. South Africa proposed to produce their national chart SAN 2003 as a stand alone chart INT 7745 for the Marion and Prince Edward Island groups. No objections were raised and consensus was reached by all members. The Chairman agreed to draft a letter to the IHB and the Chairman of CSPCWG requesting final acceptance of this chart into the INT charting scheme. (Action item 12).

However, the RHC has the dilemma in that the Australian Hydrographic Service (AHS), the charting authority for Heard and McDonald Islands, is not part of SAIHC. The UK has indicated that it does not have the capacity to produce a chart of these islands. UK agreed to seek clarity from the AHS regarding the status of charts for these islands and the responsibility in producing chart **INT 7746**. (Action item 3).

g. Substantial changes have taken place within Walvis Bay Harbour and its approaches. Changes are the deepening through dredging, added aids to navigation and the extension of the main navigation channel. The existing harbour and approach chart SAN 1001-INT 2611 no longer fully complies with charting requirements. Two separate charts are being considered as approved by the Namibian Ports Authority (NAMPORT). This means that Chart SAN 1001-INT 2611 will have to be cancelled. South Africa proposed to produce two replacement charts, INT 2612 (SAN 1004) and INT 2613 (SAN 1005). No objections were raised and consensus was reached by all members. The Chairman agreed to draft a letter to the IHB and the Chairman of CSPCWG requesting final acceptance of these charts into the INT charting scheme. (Action item 13).

NAVAREA VII Self Assessment

Mr Nelson (SA) gave a brief introduction on Maritime Safety Information (MSI). He emphasised the need for MSI, especially in the Great Rift Valley Lakes region. Mention was made of the geographical area identified as a new Sub-Area NAVAREA VIIA as a division of NAVAREA VII for the region. A copy of the WWNWS CD which contains detailed GMDSS and MSI information was distributed mainly for the benefit of associated member states.

ENC Production Status

The Chairman provided feedback on the ENC coverage within Region H. ENC coverage is similar to that of INT Chart coverage and this is mainly due to the sterling efforts of the SAIHC Member states with charting responsibilities. Deficiencies in charting coverage will only be improved through modern surveys as the lack of data is the main inhibiter.

5.2 Bilateral and Regional cooperation agreements, projects and Regional CB Management Plan

SAIHC Capacity Building Management Plan.

- a. The Chairman gave feedback on the current status of the Management Plan. Two Technical visits completed was Namibia, visited by South Africa and the United Kingdom and Malawi, visited by South Africa and Norway. Reports of these visits have been provided to the recipient countries and are available on the IHO website. Several Technical visits were conducted under the WIOMHCCP Project funded by the World Bank and the technical reports have been made available. A technical and advisory visit to the Comoros was conducted by France. Portugal confirmed that the technical visit to Angola by Portugal and Norway will take place in 2012.
- b. The Chairman gave feedback on courses and workshops:
 - i. Port and Shallow Water Surveys course in Fish Hoek, South Africa from 14 18 November 2011. The Chairman reminded delegates to provide nominations and requested that only candidates with hydrographic survey experience or those that will be utilised in such role be nominated. Unfortunately only one candidate per country can be accommodated.
 - ii. Phase 1 Skills and Chart Awareness course in 2012. The venue is still to be decided. However, it is recommended that the course be

held in Nairobi, Kenya as they previously indicated their willingness to host the course.

c. The NIOHC Capacity Building co-ordinator, Mr Jeff Bryant (UK) gave an overview of the capacity building requirements and the courses available. He created a spreadsheet for each country to consider exactly the requirements they needed. Each participating country was asked to populate the spreadsheet by the end of the meeting. He would then consolidate the gathered information and create a final populated spreadsheet for distribution. (Action item 14).

Generic Bilateral Agreement for Provision of Hydrographic Services.

The Chairman referred to the Generic Bilateral Agreement for the provision of Hydrographic Services created by France which was re-included in the Conference documents for those Member States who still have to obtain a copy. This is considered as a very good example of the type of agreement that can be used by MS and associated members who require hydrographic services or wish to enter into a Bilateral Agreement with another contracting government, to comply with the SOLAS Convention obligations.

5.3. Presentation of National Reports

The Chairman requested, due to time constraints, that all MS only highlight the most important issues, as all National Reports were available on the IHO website as meeting documents.

- a. <u>France</u>. Presented a comprehensive overview of SHOM and feedback on their recent surveys conducted in 2010. The Chairman commented that member states must be careful of duplicating work in areas where surveys already exist. He reminded everyone to forward all survey data to the relevant charting authorities. (Action Item 15).
- b. **South Africa**. There were no comments or questions.
- c. <u>Portugal</u>. The Chairman commented that due to lack of information provided to Portugal, several ENCs from Cape Verde, Angola and Mozambique could not be updated. He also commended Portugal on the translation of IHO C-13, Manual of Hydrography, into Portuguese. This will improve capacity building activities in Portuguese speaking countries.
- d. **Mauritius**. There were no comments or questions.

WEDNESDAY 7 SEPTEMBER

e. Kenya. RAdm (JG)(Ret) Neil Guy commented on the AIS Stations along the coast. There are now several stations along the coast and it is an on-going programme. IALA commented on the need to improve MSI in Kenya, specifically in accordance with IHO Standards. The Chairman enquired as to whether Kenya had done surveys in their areas of responsibility and why this data was not displayed on relevant charts. Kenya indicated that they had some raw and processed data from the extended continental shelf project, but they do not have most of the data. Mozambique indicated that they had also not received their data from the extended continental shelf project. USA agreed to investigate this and ensure that Kenya and Mozambique received the survey data of their territorial waters. (Action Item 16).

- f. <u>Mozambique</u>. Indicated a correction to their National Report. The number of buoys in the Port of Beira should read 22 and not 25 as reflected. There were no comments or questions.
- g. <u>Malawi</u>. A minute silence was observed in memory of the late Mr Gondwe, the Surveyor General of Malawi. Malawi thanked Norway for the financial support and thus making it possible for them to attend the meeting. The Chairman noted that in the National Report mention was made of a joint survey project completed in 2007 between Malawi and Mozambique. He requested that Malawi and Mozambique ensure that in cooperation the survey data and chart exchange for this project take place. (Action Item 17). The Chairman recommended that Malawi request a technical expert to assist them with getting their survey system operational once vessel R.V. TIMBA is operational. (Action Item 18).
- h. **Norway**. Norway added that even though they have only been online with PoD for 6 months that it has proved to be very successful. There where no further comments or questions.
- i. <u>Seychelles.</u> All regretted the absence of Seychelles at the meeting. A National Report was not submitted.
- j. <u>Namibia</u>. Namibia highlighted some important issues from their National Report. Namibia is at yet not an IHO member state but indicated that it is their intention to become a member in the near future.
- k. <u>United Kingdom</u>. The UKHO reiterated their willingness to assist member states within the RHC region with any requests for survey assistance. It will be assessed within the MOD, with advice from the UKHO. The Chairman requested that members take note of paragraph *1.5 Cooperation and Partnerships* of the UK National Report. The Chairman pointed out an amendment to page 4. INT 7533 should reflect against national chart NC 4160.
- I. <u>Angola</u>. Their National Report was received at the meeting. Norway enquired as to the progress being made collecting survey data from private companies. In response Angola said that very little progress had been made. Angola was asked if they were still intending to become members of IALA? In response Angola replied, not at this time. A discussion was held in relation to the standards of private surveys versus surveys carried out in relation to IHO survey standards. The Chairman requested that Norway and Portugal take note of Angola's National Report in light of their upcoming technical visit.
- m. <u>Tanzania</u>. All regretted the absence of Tanzania at the meeting.
- n. <u>Madagascar.</u> All regretted that Madagascar had to depart early. Nonetheless, Madagascar submitted a National Report which is available on the IHO SAIHC website.
- o. <u>Comoros.</u> All regretted the absence of Comoros at the meeting. Nonetheless, Comoros submitted a National Report which is available on the IHO, SAIHC website. The Chairman indicated that he had received a request from Comoros indicating that they were not reflected in the IHO Yearbook. The Chairman indicated that he will forward their details to the IHB to be included in the Yearbook. (Action Item 19).

p. <u>United States of America.</u> USA gave feedback on their operations in the SAIHC region. France, as the primary charting authority in some of the areas where the USA is surveying, had no knowledge of these activities. USA recommends that the countries themselves inform SHOM, as their charting authority.

5.4. Hydrographic Charting and Survey Status (C-55)

The Chairman gave feedback on the current status of C-55. He encouraged all MS to check their respective details in IHO Special Publication C-55 on the IHO website and provide updates of their charting and survey status. He stressed the importance thereof and remarked that all MS should strive to provide an update at least once a year. The IMO stated that they have forwarded this request to all their members and as yet had no response.

5.5. Procedures in response to Marine Disasters

The Chairman indicated that an emergency point of contact list for Marine Disaster Management responders will be compiled and circulated to member states for comment. It will remain a standing agenda item. (Action Item 20).

Agenda item 6: Marine/Hydrographic Spatial Data Infrastructure (SDI)

The Chairman stated that geographic spatial data is lacking in the SAIHC region and may require some capacity building actions. The UK commented that the Capacity Building Sub-Committee has approved an MSDI – Data Management of Marine Date course in 2012, for SAIHC and NIOHC, as MSDI is a relatively new concept. This concept is described in IHO C-17. The MSDI Course is a one week training course encompassing all the themes of database management and the principles of bringing sea and land "together".

Agenda item 7: Feedback on the Marine Highway Project

RAdm (JG)(Ret) Neil Guy gave a presentation covering this project keeping all informed of its current status.

Agenda item 8: Statutes of SAIHC

Mr Franck Razafindrabe, the General Manager of the Geographic and Hydrographic Institute of Madagascar, signed the statutes at the meeting before his departure. Angola is the only country still in need to sign the statutes.

The Chairman stated that the SAIHC Statutes be amended to reflect annual meetings, as well as the venues for the meetings be amended to allow for the SAIHC meetings to be held outside of the SAIHC region. This will be reflected as an Amendment to the Statutes. (Action item 21).

Agenda item 9: Any other Business

The IMO presented a report on the Capacity Building Programme.

IALA gave a presentation on General Maritime Safety and MSI. IALA indicated that a questionnaire had been distributed, but had not received many back. The Chairman urged all Member States and associate Member States within the SAIHC region to respond to the questionnaire. The Chairman will send out a reminder regarding this. (Action Item 23).

SAMSA gave a presentation on a proposal to *Reconvene the Regional Co-Operation Group on Safety of Navigation and Marine Environmental Protection (SAGNEP)*. SAMSA gave a summary of the Terms of Reference (TOR) for SAGNEP as well as indicated that SAMSA is willing to host the first reconvened meeting in 2012. SAMSA requested SAIHC's support on the reconvening of SAGNEP. The Chairman assured SAMSA that full support will be provided. The Chairman requested that a draft agenda for SAGNEP be created for input by SAIHC member states. He also requested a copy of the TOR and a proposed participant list be forwarded to himself to be distributed to all SAIHC Members. (Action Item 24).

Agenda item 10: Election of Chairman and Vice-Chairman

Captain Abri Kampfer of South Africa and Mr Abdool Oozeer of Mauritius indicated their willingness to stand another term as Chairman and Vice-Chairman respectively. All members present voted in support of this.

Captain Abri Kampfer was re-elected Chairman of SAIHC. Mr Abdool Oozeer was re-elected as Vice-Chairman.

Agenda item 11: Date and Location of the next Conference

Mauritius indicated that they would be prepared to host the 9th SAIHC Conference in September 2012. Dates and venue is still to be confirmed. **(Action Item 22).** Portugal has indicated their willingness to host the 10th SAIHC Conference in 2013 in Lisbon, Portugal. **(Action Item 25).**

Agenda item 12: Closure

Before closing, the Chairman reviewed the summary of the Action Items. All members present agreed that it was a true reflection of the meeting discussions. (Annexure C).

The Chairman thanked all participants for their attendance and inputs at the meeting. The Chairman formally declared the meeting closed at 14:30. Thereafter NAMPORT arranged for all participants to be taken on a coastal bus trip to Swakopmund jetty, the lighthouse and surroundings, including a visit to Dune 7.
