

**NOMINATION OF CANDIDATES
FOR THE POSTS OF CHAIRMAN AND VICE-CHAIRMAN OF
THE IHO FINANCE COMMITTEE**

To: All Members of the IHO Finance Committee.

Reference: IHO General Regulations, Article 11 (c).

Dear Sir or Madam,

1. The Bureau has recently received two letters concerning Finance Committee Officers: the first one, from the External Relations Department of the Principality of Monaco, informs us that Mr. Jean-Claude MICHEL does not wish to continue as Chairman of the Finance Committee, whereas the second letter, from the United Kingdom Hydrographic Office, indicates that Mr. Bill BURGESS will no longer be able to continue as a Member of the Finance Committee, and will have to relinquish the post of Vice-Chairman.

2. Both letters propose replacements for these two FC Officers : Monaco proposes Mr. Maurice GAZIELLO, senior civil servant who is at present the Government Financial Controller General for Monaco, whereas the UK Hydrographic Office proposes Mr. Barrie BUSSEY, Finance Director of the UKHO.



Whilst regretting the simultaneous departures of these two officers of this important Committee, the Directing Committee of the International Hydrographic Bureau warmly thanks these two countries for nominating candidates which will enable the next meeting of the Finance Committee Officers to be held on its normal date in November with the new Directing Committee which has just been elected.

Therefore, except if other nominations for these posts are received by 15 July 2002, the Directing Committee would ask you to approve the above-mentioned candidates, i.e. Mr. GAZIELLO, new Finance Committee Member for Monaco for the post of Finance Committee Chairman and to elect to the post of Vice-Chairman, the British candidate, Mr. Bussey.

5. In conclusion, the Directing Committee invites you to inform the Bureau if your country wishes to nominate a candidate for the Finance Committee Officers, or if not, requests you to vote on the choice of the new Chairman and Vice-Chairman of this Committee.
